1. Welcome and Introductions

The meeting began at 3:02 pm. Both virtual and in-person attendees introduced themselves.

2. Approve minutes from September 11th, 2024 meeting

A motion to approve the September 11th minutes was made by E. Hodgson and seconded by K. McCamy. The minutes passed unanimously.

3. Public input opportunity

One member of the public was present at the time of the public input opportunity, however there were no public comments made.

4. Bike/Ped Committee Citizen Representative

In early September Metro COG solicited for a second citizen representative to serve on the Bicycle & Pedestrian Committee. Metro COG received a total of nine applications. A selection committee comprised of representation from the jurisdictions of Horace, West Fargo, Fargo, Moorhead, and Dilworth was used to review the applications. Due to the competitive nature of the applications, the selection committee narrowed the applications down to the top three with the top three asked to participate in brief in-person interviews.

Upon interviews, Terry Steen, was the top ranked applicant. Pending approval by the Committee, Mr. Steen will serve the two-year term beginning January 1, 2025 and ending December 31, 2026.

A motion to approve Terry Steen as this solicitation's Bicycle & Pedestrian Committee's Citizen Rep was made by P. Mastera and seconded by T. Trowbridge. The motion was passed unanimously.

5. Procedure for Bike-Ped Committee Citizen Rep

D. Farnsworth described the current procedure for the two Bike/Ped Committee citizen representative seats. The current procedure allows for the citizen rep to be offered to serve another two years once their first two-year term is complete. However, Metro COG, in agreement with the citizen rep selection group felt this could be confusing for candidates and doesn't tap into the many quality interested candidates as frequently. Therefore, Metro COG is requesting this option for a two-year extension be excluded.

Another suggestion from Metro COG and the citizen rep selection group was to keep applications on-file for two years. This wouldn't require reapplying candidates to reapply every year. This would also retain interested candidates who may be discouraged from applying due to not being chosen in past years.

It was asked if applicants who've already served can reapply. After discussion, P. Mastera suggested that a person who's already served a term can't reapply immediately, but could reapply one year after their term has expired. For example, if their term expired Dec 31 2026, they could reapply in the September 2027 solicitation for the Jan 1, 2028 – Dec 31, 2029 term. Selection of that individual to serve on the Committee would be at the discretion of the representative selection group.

A motion for this new procedure was made by P. Mastera and seconded by F. Steinhoff. The motion is as follows: Omit offering a second term to citizen representatives immediately after their term, keep applications of applicants on-file for two years, and allow any serving citizen representatives to reapply one year after their term has expired.

6. Revised Transportation Alternatives (TA) Scoring

- P. Bervik walked through proposed revisions to the TA as recommended by the Bicycle & Pedestrian Committee in 2023. Bervik noted that a subcommittee met to revise the TA scoring criteria during the summer/fall of 2024. Bervik presented the proposed changes to the scoring criteria. These included:
 - Urban TA Criteria: 5 points for maintenance projects which are not specified in a plan. This applies to the plan/study scoring criteria.
 - Rural TA Criteria: 10 points for a project that maintains or rehabilitates an existing facility.
 - A change to the environmental justice map. The revised map used the Census tract groups rather than the Census block groups and also broke the income groups into 'Below Median Household Income' and 'Below Environmental Justice Parameters'.

7. Review & scoring of urban TA applications

- P. Bervik walked through the urban TA applications by briefly describing each project for which an application was submitted. Bervik then went through the scoring with the Committee for each project, pointing out the scoring for which he wanted the Committee's concurrence. None of the scores for the projects needed adjusting, however there were a few comments from Committee members requesting changes/considerations to scoring criteria in the future. Comments/changes/considerations to the scoring criteria were as follows:
 - School proximity criteria T. Trowbridge suggested considering a range of points for various distances.
 - Land use criteria It was suggested that in the future industrial land use should also be included, similar to commercial land use.

As a result of the scoring, the projects were scored as follows:

- City of Fargo Drain 27/Deer Creek Shared Use Path Phase 1 30 pts
- City of Fargo Drain 27/Deer Creek Shared Use Path Phase 2 30 pts
- City of Fargo Low Level Drain 53 Crossing 20 pts
- City of Fargo Drain 53 Shared Use Path (64th Ave S to 73rd Ave S) 20 pts
- City of West Fargo Westside Elementary Area Pedestrian Ramps 50 pts
- City of West Fargo 8th Street Shared Use Path Reconstruct 50 pts
- City of West Fargo Beaton Dr Shared Use Path 25 pts
- City of Moorhead Bluestem Bridge Pedestrian Bridge 35 pts

A motion to approve the scoring of the projects as shown was made by F. Steinhoff and seconded by K. McCamy. The motion was passed unanimously.

8. Review & scoring of rural TA applications

P. Bervik described the one rural TA application – a Cass County application for the reconstruction of a shared use path in Kindred. Bervik then went through the scoring with

the Committee. The Committee concurred with the scoring as presented. The scoring yielded 55 points for the Cass County / Kindred shared use path reconstruction project.

A motion to approve the scoring of the projects as shown was made by M. Elshaug and seconded by C. Stetz. The motion was passed unanimously.

9. Project updates

Clay County Heartland Trail Study

D. Farnsworth provided an update on the Heartland Trail Study in Clay County. Farnsworth noted that the study has narrowed down the alignments to one alignment. Farnsworth described the alignment and noted the opportunities and challenges with the alignment. He pointed out that a public open house will be held on Monday Dec 9th at the MSUM Science Center for the Buffalo River State Park management plan. Farnsworth encouraged the public and those interested in attending or to participate online. The Heartland Trail Study in Clay County is anticipated to be wrapped up in March of 2025.

Moorhead Safe Routes to School Plan

D. Farnsworth provided an update on the Moorhead Safe Routes to School Plan. He noted that this plan has been moving quickly, with work kicked off in the beginning of 2024. Metro COG is wrapping up the plan right now with a draft plan anticipated to be released to the public and study review committee by the end of the week.

Bike Map App update

D. Farnsworth updated the Committee on updates & fixes to the Fargo Moorhead Bike Map app. This app, which can be found on Metro COG's website and also downloaded via Apple Store or Google Play, is in the process of being updated. Metro COG strives to update the bikeway network on the app every two years or so. He also pointed out that the app may not be working via Google Play at the time being, but they are working with the app developer to get this resolved.

Bicycle Friendly Community Application update

D. Farnsworth noted that Metro COG submitted an application for Bicycle Friendly Community in June of 2024. This application is for the Fargo-Moorhead Metro Area, which includes Fargo, West Fargo, Moorhead, Horace, and Dilworth. Applicants are anticipated to hear from the League of American Bicyclists by the end of the year about any potential awards. Farnsworth pointed out that Metro COG applied and was awarded Bronze designation in 2014 and 2018. The FM Area hopes to be awarded Bronze again, or possibly even Silver.

Installation of new bicycle & pedestrian counters

Bervik provided an update on the installation of new bicycle & pedestrian counters which Metro COG ordered in 2024. Bervik mentioned the Committee's involvement in selecting locations of future counter locations in the past. Metro COG was able to order eight

counters in 2024 which are currently being installed. Of the eight counters ordered, five have been installed thus far. Metro COG plans to install the other counters by the end of 2024. Bervik pointed out that data from the counters can be provided to jurisdictions via the data dashboard. Metro COG plans to provide jurisdictions with this access after all counters are set up.

10. Other business

There was no other business. The meeting was adjourned around 4:45 pm.

1. Welcome and Introductions

The meeting began at 3:03 pm. Both virtual and in-person attendees introduced themselves.

2. Minutes from December 4th, 2024 meeting

A quorum was not present at this meeting. Therefore, the December 4th meeting minutes were not approved. The December 4th minutes will be brought forward at the next meeting for approval.

3. Public input opportunity

While there were non-members (potential public) present at the meeting, no public comments were brought forward during the public comment opportunity.

4. Updated Bicycle & Pedestrian Committee members

With some new members on the Bicycle & Pedestrian Committee, D. Farnsworth reviewed the current list of members on the Metropolitan Bicycle & Pedestrian Committee with the Committee. New members since the last meeting include: Amy Zundel (West Fargo Parks) and Terry Steen (Citizen Representative). It was noted that there is currently a vacant seat for West Fargo Planning since Leslie McGillivray-Rivas is no longer with the city of West Fargo.

5. Bicycle Friendly Community Report Card

D. Farnsworth went through the Bicycle Friendly Community report card which was provided to Metro COG when the Fargo-Moorhead community obtained bronze designation by the League of American Bicyclists in January. Per the report card, the F-M community receiver higher scores in the categories of Engineering and Evaluation/Planning while receiving lower scores in Education, Encouragement, and Equity/Accessibility.

There was discussion about how local bicycle/pedestrian projects can be quantified as a way of tracking progress. It was suggested that Metro COG and the Bicycle & Pedestrian Committee could possibly develop a method for tracking the implementation of bicycle/pedestrian projects and improvements.

The Committee then reviewed the "Feedback to Improve" which the League of American Bicyclists provided in the report card. One of the feedback items listed was – *Encourage more local businesses, agencies and organizations to promote cycling and seek recognition through Bicycle Friendly Business programs*. D. Farnsworth noted that Metro COG will reach out to businesses and jurisdictions to encourage them to apply for Bicycle Friendly Business.

Another feedback item was – Expand bicycle wayfinding to more strategic locations around the community. There was some discussion around this item. Farnsworth noted that he would like to work with jurisdictions about improving bicycle wayfinding in the future.

There was then discussion about the need for more bicycle safety education for both adults and children, followed by discussion about recommendations for more and higher quality bicycle parking (which meets APBP standards).

6. Clay County Heartland Trail Study Update

D. Farnsworth provided the Committee with an overview of the Heartland Trail Study in Clay County, discussing the alignment, phasing, and next steps. A draft plan is anticipated to be sent to the public within a couple weeks with a final plan and adoption anticipated in May/June.

7. West Fargo Safe Routes to School Plan Update

A. Jung discussed the recently kicked-off West Fargo Safe Routes to School Plan with the Committee. This plan, which will be developed in-house by Metro COG, will be a two-year process with schools located north of I-94 studied in 2025 and schools south of I-94 in 2026. Since the West Fargo School District includes schools in Harwood and Horace, those schools will be included as well. C. Hansen asked if Cass County could be part of the plan's study review committee since several schools are next to county roadways. Metro COG will forward Cole Hansen the meeting invite, which he can then forward to the proper county staff member.

A. Jung discussed that the plan won't include West Fargo Public Schools located within the city of Fargo, with the exception of Meadowlark Elementary which was constructed after completion of the Fargo Safe Route to School Plan.

It was also suggested that West Fargo Parks be included on the study review committee too. Metro COG will forward A. Zundel the meeting invite.

8. Fargo-Moorhead Bike Map App Update

D. Farnsworth provided a brief overview of the Fargo-Moorhead bike map app and noted the challenges they are having with the app developer. Metro COG provided the app developer with the latest bikeways in August of 2024 and the developer has yet to implement the updates, despite over 20 back-forth emails. D. Farnsworth stated that Metro COG can no longer depend on this app developer and another solution will need to take place.

Farnsworth noted that they have been looking into potential new app developers, but noted the costs of other developers far exceeds the cost allocated for the existing app developer.

J. Atkins suggested Metro COG should consider Field Maps and noted that Moorhead uses that for various purposes and is satisfied with the product. Field Maps is an ESRI tool which Metro COG already has a license to. Atkins suggested getting in touch with Moorhead's GIS lead, Michael. J. Hanks also noted that Horace uses Field Maps. Metro COG will follow-up to learn more about the potential use of this tool to possibly substitute the current version of the Fargo-Moorhead bike map app.

9. Agency Updates

Dilworth

P. Mastera noted that the state is in the design phase of Hwy 10 in Dilworth, which will include improved sidewalk/path along Hwy 10. Mastera also noted the Dilworth is updating their comprehensive plan.

Horace

J. Hellman mentioned that Horace is planning for a continuous shared use path along the west side of Drain 27 from the Fargo city limits to the FM Diversion southern embankment.

Fargo

- J. Gorden listed several projects that are being designed or constructed in Fargo. These include:
 - A shared use path along the Red River in the vicinity of the VA hospital
 - Phase II of a shared use path along the Red River between 32nd Ave S and 40th Ave S in south Fargo
 - A crossing of Rose Creek in south Fargo
 - A shared use path on the west side of Drain 27 near Deer Creek neighborhood

Moorhead

J. Atkins noted that Moorhead will be reconstructing 34th St which will include the reconstruction of the shared use path. While under construction, they plan to have the bicycle/pedestrian detour on a dedicated on-street facility because otherwise the bike/ped detour would be up to two miles.

Atkins also noted that (for the first time) Moorhead is gathering ride quality using the ride quality index (RQI) on the shared use paths in Moorhead. This will help Moorhead determine which paths should be prioritized for replacement.

F. Steinhoff mentioned that Moorhead plans to looking into improved bicycle parking in Moorhead.

West Fargo

A Zundel noted that West Fargo Parks is interested in connecting downtown West Fargo to Armour Park with a bridge across the Sheyenne River. She also noted that they are looking at a potential bicycle safety park at one of the parks in West Fargo. D. Farnsworth expressed excitement for a bicycle safety park noting the ongoing need in the Fargo-Moorhead area for better bicycle safety education.

Zundel also noted improvements to existing paths which would include mill & overlay projects and replacing paths with concrete.

10. Other business

There was no other additional business. The meeting was adjourned around 4:25 pm.

Re: Fargo-Moorhead Bike Map App update

At the last Bicycle & Pedestrian Committee meeting, Metro COG staff noted that the developer of the current <u>FM Bike Map App</u> is no longer reliable and may no longer be operational. Therefore, it was suggested that Metro COG look into a GIS-based tool to develop a bike map in-house. After the Committee meeting, Metro COG staff reached out to Moorhead GIS staff to discuss the possibility of Metro COG creating and maintaining a GIS-based online public map using Metro COG's existing GIS (ESRI) software license.

It was determined that ESRI's Experience Builder tool would work well for a future online public map. Developing a map with this tool would allow the map to include the same features as the current bike map app, including a user's GPS location if desired. Using this tool, Metro COG staff would be able to update the map at will so that the bikeways could regularly be updated.

At the June 18th Bicycle & Pedestrian Committee meeting, Metro COG staff will show the Committee the draft online map which was developed and demonstrate its capabilities. This map could also be linked to a QR code allowing users to easily access the map without downloading an app.

At the meeting, Metro COG will also show the Committee, and solicit feedback, on logos staff created to be used for a new Fargo-Moorhead Bike Map App.

In addition to the online map, Metro COG is considering developing and printing paper bikeways maps. Since discontinuing the paper maps in 2018, Metro COG has received numerous requests for paper maps over the years. Metro COG feels both paper maps and a digital map would best meet the needs of the area's diverse population.

Re: Past plans - implementation tracking

At the last Bicycle & Pedestrian Committee meeting, it was suggested that Metro COG look at past bicycle/pedestrian plans to gauge the progress made on the plans' recommendations.

Metro COG referenced recent Metro COG-led plans and developed a table of infrastructure recommendations within each plan. The plans Metro COG referenced are the following:

- Moorhead Safe Routes to School Plan (2025)
- DGF Safe Routes to School Plan (2023)
- Red River Greenway Study (2023)
- Fargo Safe Routes to School Plan (2020)
- FM Diversion Greenway Master Plan (2020)
- FM Bicycle & Pedestrian Plan (2019)
- FM Bikeways Gap Analysis (2019)

The attached table summarizes infrastructure recommendations from each plan, notes the jurisdiction(s) responsible for implementation, and notes the progress of each recommendation.

The Committee will discuss this potential tracking effort further at the June 18th meeting. If the Committee would like to pursue such tracking, Metro COG would ask that each jurisdiction dedicate the necessary time to help Metro COG update the status of each applicable recommendation.



Re: Clay County Heartland Trail Task Force composition

As the Heartland Trail Study in Clay County wraps up, a committee or task force should be established to guide and ensure ongoing progress of Heartland Trail planning efforts.

The Clay County Heartland Trail Task Force was formed in 2014 and met regularly in the following years. However, meetings because less frequent over the years with the last meeting occurring in early 2020. Also, the Task Force was rather large with 26 member seats and three advisory member seats when the last meeting occurred.

It was suggested that the Bicycle & Pedestrian Committee revisit the composition of the Clay County Heartland Trail Task Force to update current members assigned to the Task Force and to ensure the appropriate stakeholders and agencies are represented.

The Clay County Heartland Trail Task Force (as of 2020) is shown on the following page. The Bicycle & Pedestrian Committee will discuss the future composition of the Task Force at the June 18th Bicycle & Pedestrian Committee meeting.

When discussing, considerations could include:

- Should the Task Force be comprised of technical staff, elected officials, or a combination thereof?
- How large should the Task Force be? How large is too large?
- What roles should the Task Force include? Planning? Guidance? Lobbying? Advocacy?
- How many representatives should represent each jurisdiction? Should some jurisdictions have several representatives?
