The TH10 Corridor Study through Dilworth identified 8th Avenue N as a corridor that could be improved to make regional connections as an alternative to TH10, particularly if a 3lane option is selected. The future 8th Avenue N connection in Dilworth would provide direct connection to Walmart and the surrounding shopping areas along 34th Street.

Metro COG included this study in its UPWP Amendment #5 that will utilize unspent 2023 CPG funds. The RFP identified a budget of \$150,000 with a mandatory completion date of December 31, 2024. The local match is being provided by the City of Dilworth.

Metro COG received one proposal prior to the proposal deadline on Wednesday, July 17, 2024. Apex Engineering was the only proposing consultant firm.

Metro COG asked, and was granted, a waiver by NDDOT from the minimum proposal requirement listed within the Consultant Administrative Services (CAS) manual. Subsequently, Metro COG convened a consultant selection panel met with and interviewed the consultant team on Wednesday, July 23rd to further understand the technical qualifications of the proposing consultant, their approach to the project, task deliverables, and past project experiences. The selection was based upon scoring criteria, written technical proposals, and the in-person interviews.

The Selection Committee interviewed the proposing consultant team and determined that the team had the sufficient expertise, background knowledge of the area, and project approach to successfully complete the planning effort. The selection committee unanimously agreed to select Apex Engineering with subconsultants TC2 and HKGi to complete the Dilworth 8th Avenue Extension Study.

Due to the aggressive timeline scheduled for this project, Metro COG is asking for an email vote by the TTC to accept the findings of the Selection Committee and allow Metro COG to enter into a contract with Apex. Metro COG will be holding a special session of the Policy Board on July 29th at 10:00 a.m. Metro COG is scheduling a meeting with Apex to develop the final project scope of work.

Metro COG opened the sealed cost proposal submitted by Apex, and their proposed cost of \$149,942.96 was within the budgeted amount as listed in the RFP.

Requested Action: Approval of Apex Engineering with subconsultants TC2 and HKGi as the preferred team recommended by the study's consultant selection panel to complete the study and authorize Executive Director to enter into a contract with said consulting team for the Dilworth 8th Avenue Extension Study.

Re: Kindred Comprehensive & Transportation Plan Consultant Selection

Metro COG and the City of Kindred are seeking professional consultant services to complete the first comprehensive and transportation plan for Kindred. This plan will examine existing conditions and economic, demographic, and social trends in the city and surrounding area, as well as an in-depth look at transportation and related infrastructure needs. Emphasis will also be placed on an assessment of existing land use patterns, an analysis of supplementary planning strategies, goals and policies, and an action and implementation matrix to achieve community objectives and initiatives.

In June, Metro COG's Policy Board approved the RFP to secure a consultant to complete the technical and planning tasks outlined in the scope of work under an approved budget of \$100,000. Metro COG received five proposals before the July 18 closing date from the following lead consultants: Bolton & Menk, Houston Engineering, KLJ, SRF, and WSB. The selection committee met with and interviewed consultants on July 24 to further understand each consultant's technical qualifications, task deliverables, and past project experience. Selection committee members included:

Adam Altenburg, Metro COG Tabitha Arnaud, City of Kindred Kyle Litchy, Cass County Christina Woller, Kindred P&Z

Based on scoring criteria, written technical proposals, and in-person interviews, the selection committee has chosen the proposal submitted by Bolton & Menk.

The initial cost proposal form submitted by Bolton & Menk is \$99,986.60. Total project costs would be split 72 percent between Metro COG's federal Consolidated Planning Grant (CPG) funds and a 28 percent local match from the City of Kindred and Cass County.

Requested Action: Approve the selection of Bolton & Menk to complete the Kindred Comprehensive and Transportation Plan pending contract negotiations to finalize the scope and fee.

Re: Metro Railroad Needs Study – Consultant Selection

The Metro Railroad Needs Study has been identified as a high priority for the F-M region. It will examine at-grade crossings for possible closure or gradeseparated improvements, safety, quiet zones, multi-modal traffic conflicts and constraints, as well as railroad operations. The study is part of Metro COG's UPWP and has a programmed budget of \$400,000. Local match, including overmatch, will be provided by BNSF.

Metro COG received four proposals prior to the deadline on Wednesday, July 17, 2024. Proposals were received from the following consultant Teams:

- Stantec with subconsultant TC2
- SRF with subconsultant quèt•ica •
- Ulteig with subconsultants benesch and Leutz Graphics
- HDR

The Consultant Selection Committee met with and interviewed the consultant teams on Wednesday, July 24, 2024 to further understand their technical qualifications, project approach, task deliverables, and past project experiences. The selection was based upon scoring criteria, written technical proposals, and the in-person/virtual interviews.

The Selection Committee interviewed the proposing consultant teams, scored and ranked each team. After rankings were tallied, HDR was preferred by the Selection Committee to complete the Metro Railroad Needs Study.

Due to the aggressive timeline scheduled for this project, Metro COG is asking for an e-mail vote by the TTC to accept the findings of the Selection Committee and allow Metro COG to enter into a contract with HDR. Metro COG will be holding a special call meeting of the Policy Board on Monday, July 29, 2024 at 10:00 AM seeking approval of HDR as the preferred consultant recommended by the Selection Committee.

Metro COG opened the sealed cost proposal submitted by HDR, and their proposed cost of \$399,979.96 is within the budgeted amount as listed in the RFP.

Requested Action: Recommend approval of HDR as the preferred consultant as recommended by the Selection Committee to complete the study and authorize the Executive Director to enter into a contract with HDR for the Metro Railroad Needs Study.
