Preparation of Metro COG's Unified Planning Work Program

Metro COG is beginning the process of creating the 2013-2014 Unified Planning Work Program (UPWP). The UPWP includes all Metro COG project activities and reflects the priority planning needs of the metropolitan area. The **UPWP** serves as the technical planning tool to refine and define the transportation needs of the metropolitan area.

What is the UPWP?

The UPWP is the list of projects that Metro COG undertakes over a two year period. A listing of 2011 UPWP accomplishments is listed on the back page of this newsletter.

Why is this important?

Metro COG acts as the metropolitan planning organization (MPO) for the Fargo-Moorhead area and supports planning and programming to address transportation needs and issues. Metro COG coordinates local, state, and federal activities. In order to ensure the funding is used appropriately, the public is encouraged to provide feedback on the transportation priorities of the metropolitan area.

Who approves the UPWP?

The first step of the UPWP update is to gather input from area interested persons, local units of government, and the public. This edition of Metro Connection serves as Metro COG's notice regarding its intent to update the UPWP. In March and early April Metro COG will meet with local and state technical staff to determine

their priorities and planning needs. The Metro COG Policy Board will eventually approve and adopt the UPWP later in the fall of 2012.

What happens after the UPWP is approved?

Projects listed in the 2013-2014 UPWP will be studied and analyzed, and will result in the development of policy, planning and programming related recommendations. Eventually, funding may be identified and projects may be constructed or policies may be changed to reflect the results from UPWP projects.

How can I get involved?

Enclosed in this newsletter is a survey. Complete and return the survey to assist in identifying metropolitan transportation planning needs. A UPWP survey is also available through Metro COG's website.

Metro COG will be hosting a Community Transportation Forum on Tuesday, April 3, 2012 at 3:00pm at the Metro COG offices (One 2nd Street North, Case Plaza, Suite 232, Fargo, ND 58102). Members of the public are encouraged to attend Community Forum to share input regarding the development of the UPWP, and learn more about the projects and activities of Metro COG. METRO COG New Projects

Metropolitan Demographic Forecast

Metro COG has selected the consultant team of Ulteig Engineering and McKibben Demographic Research to complete the Metropolitan Demographic Forecast Study. The Metropolitan Demographic Study will estimate population, households, and jobs in the Fargo-Moorhead metropolitan area through the year 2040. This study is completed every five years in order to maintain accurate and relevant information.

The forecasts are a crucial element to Metro COG's metropolitan planning program and specifically important in respect to efforts to maintain and update the regional travel demand model. The model produces critical information such as traffic forecasts which are based on population, households, and job patterns within the metropolitan area.

The updated Metropolitan Demographic Study will reevaluate demographic projections which consider 2010 Census numbers and assist in the development of the 2010 base year travel demand model. The Study will also be used as the basis for the Long Range Transportation Plan update, which will begin in the fall of 2012 and will cover a planning horizon to the year 2040.

Intelligent Transportation Systems Plan

In April Metro COG will start the update of Metropolitan Intelligent Transportation Systems (ITS) Plan. The ITS Plan outlines the deployment principles and strategies regarding ITS for the FM Metropolitan Area. The current ITS Plan was last approved in 2008. ITS involves the deployment of traffic detection, data collection, surveillance, and notification systems aimed at improving mobility within the FM Metropolitan area.

The ITS Plan update will focus specifically on consolidating and updating recommended actions and strategies from recently completed studies. ITS and traffic operations issues have received substantial focus by Metro COG since the 2008 ITS Plan was adopted. Based on the work of Metro COG and its partners there is now substantial consensus among local traffic operators regarding strategies to improve traffic operations within the FM Metropolitan Area through ITS deployment and signal system integration.

The update of the 2008 ITS Plan will expand upon past ITS plans and include three important additional elements: (1) a Metropolitanwide signal system assessment; (2) a Regional Concept for Traffic Operations (RCTO); and (3) Transit ITS utilization and deployment strategy. The ITS Plan update will propose ambitious improvements which will aim to improve the operations of the regions most significant surface transportation assets. Metro COG anticipates the ITS Plan update will take about a year to complete, ending in April 2013. Technical reports and other information will be periodically posted to Metro COG's website. METRO COG Public Input Opportunities

Highway 10/75, Main Avenue and Center Avenue Corridor Study

Moorhead: Center Avenue/TH 10/TH 75

Tuesday, March 27, 2012 5:30 p.m. to 7:00 p.m.

Metro COG will hold a public meeting on **Tuesday March 27, 2012 from 5:30 p.m. to 7:00 p.m.** The meeting will be an open house format. The meeting will be held at Courtyard by Marriott (1080 28th Avenue South, Moorhead, MN.) The study corridors include TH 75/8th Street (20th Ave S to Main Ave), Center Avenue (Red River to 8th Street), and TH 10 (Red River to 8th St along Main Ave, Main Ave to Center Ave along 8th St, and 8th St to TH 336 along Center Ave).

Preliminary alternatives have been developed based on issues that were identified from technical analysis and as a result of comments received at the first round of public input meetings. Some of the preliminary alternatives include access closures and modifications, turn lane additions/improvements, changes in intersection control, roadway alignment shifts, roadway jurisdictional changes, railroad grade separation, improved bicycle/pedestrian facilities, etc. The purpose of this public input meeting will be to provide an opportunity for public involvement and comments in the review of preliminary alternatives developed. No decisions have been made at this time. Your input is important to this study.

Information regarding the TH 10, TH 75, and Center Avenue Corridor Studies will be available for review in the Metro COG office (address below), or online at www.fmmetrocog.org. If you are not able to attend the public input meeting, you can join the meeting via webcast by accessing a link from Metro COG's website. The alternative layouts will be available online for viewing during the live webcasting and approximately one week prior to the public input meeting. Written comments will be accepted by Metro COG until Noon, April 3, 2012, Written comments can be submitted in writing to Metro COG at One North Second Street, Suite 232, Fargo, ND 58102; or by email at harter@fmmetrocog.org. All public comments received will be reviewed and considered by the Study Review Committee for the project and will be included within the final corridor study document. MAT Board Enters 8th Year Under Guidance of New Joint Powers Agreement

The Metropolitan Area Transit (MAT) Board entered its eighth (8th) year of proceedings in 2012. The MAT Board was originally formed in 2004 through a Joint Powers Agreement (JPA) by the Cities of Fargo and Moorhead. The MAT Board was tasked with overseeing system coordination, with a key function being the planning and development of the Metro Transit Garage.

The original JPA updated in 2007, and most recently updated in December of 2011. The MAT Board has gradually evolved to oversee an increasing sphere of MATBUS operations, with the objective to ensure the coordinated delivery of public transit within the FM Metropolitan area. Full voting membership on the MAT Board is as follows: City of Moorhead; City of Fargo; West Fargo; Dilworth; NDSU; MSUM; Concordia; M-State; and Valley Senior Services. The MAT Board is chaired by a citizen who is jointly appointed by Fargo and Moorhead. The current Chair of the MAT Board is Kevin Hanson.

Per the updated JPA, The MAT Board is responsible for recommendations to local units of governments regarding budgets, fares, U Pass agreements, Driver Service Contracts, Marketing/Outreach, Capital Planning/Facility Development, and System Operations and Service Planning.

In 2012 the MAT Board will work with Metro COG to review previous alternatives and options regarding the development of a more consolidated metropolitan transit system. MATBUS is currently a separate but highly coordinated transit system. Several studies and analysis have been completed over the past twenty five (25) years to understand options by which a single entity would be created to manage and operate public transit within the metropolitan area. In 2012 the MAT Board has asked Metro COG review past coordination concepts and develop a new framework to ensure continued coordination of transit services.
