Re: Amendment #8 to the 2022-2025 Transportation Improvement Program (TIP) for the Fargo-Moorhead Metropolitan Area

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) held a virtual public meeting via Zoom Video Communications on Thursday, September 15, 2022 at 4:00 p.m. to consider public comments regarding a proposed Amendment #8 to the 2022-2025 TIP. The public comment period officially ended at 12:00 p.m. (noon) on Thursday, September 15, 2022, prior to Policy Board action on Amendment #8. Specific information regarding the contents of Amendment #8 to the 2022-2025 TIP has been detailed in the enclosed attachments as well as being available to the public on Metro COG's website (<u>https://fmmetrocog.org/TIP</u>), within Metro COG's office, and was publically distributed within the TTC and Policy Board meeting packets. The proposed amendment to the 2022-2025 TIP reflects new federally funded projects within the Metropolitan Planning Area (MPA).

An official public notice was published in the Forum of Fargo-Moorhead on Wednesday, August 31, 2022 advertising the public meeting and opening of the public comment period. Public engagement processes for the proposed 2022-2025 TIP amendment were conducted to the adopted Metro COG Public Participation Plan (PPP). Public comment was accepted by Metro COG until 12:00 p.m. (noon) September 15, 2022, providing a 16-day public comment period. No public comments were received by Metro COG neither verbally during the public hearing nor by written statement.

The Transportation Technical Committee (TTC) recommended and the Policy Board approved the attached amendments at the regularly scheduled September 15, 2022 meeting. The updated TIP project sheet reflecting the amendment and scanned public notice, are also attached.

The Fargo-Moorhead Metropolitan Council of Governments (Metro COG) will hold a virtual public meeting via Zoom Video Communications on Thursday, September 15, 2022 at 4:00 p.m. to consider public comments regarding a proposed amendment to the 2022-2025 Transportation Improvement Program (TIP) for the FM Metropolitan Area. The proposed amendment to the 2022-2025 TIP reflects a modified federally funded project within the Metropolitan Planning Area (MPA).

A public notice was published in The Forum of Fargo-Moorhead on Wednesday, August 31, 2022, which advertised the public meeting, detailed how to request more information, and provided information on how to make public comment regarding the proposed amendment. The public notice advertised that public comments will be accepted until 12:00 p.m. (noon) on Thursday, September 15, 2022. As of the writing of this memo, no written comments have been received.

The proposed amendment to the 2022-2025 TIP is as follows:

- 1. Modification of Project 9190025: NDDOT reconstruction of I-94 E from near W Fargo E to W Horace Rd. The project year changed from 2023 to 2022. The total project cost increased by 31.02% from \$8,200,000 to \$10,743,764 of which Interstate Maintenance (IM) funds increased from \$7,380,000 to \$9,669,388 and state funds increased from \$820,000 to \$1,074,376.
- 2. Modification of Project 9190027: NDDOT reconstruction of I-94 W from near W Farao E to W Horace Rd. The project year changed from 2023 to 2022. The total project cost increased by 31.02% from \$8,200,000 to \$10,743,764 of which Interstate Maintenance (IM) funds increased from \$7,380,000 to \$9,669,388 and state funds increased from \$820,000 to \$1,074,376.
- 3. Modification of Project 9221002: NDDOT Wrong Way Detection System safety project at I-29 Exit 69. The project year changed from 2022 to 2023.
